**Topic(s): Topic: DR: Establishment and operation of a solar farm at 415 Moroa Road, and other roads – Greytown**

I am a person who has an interest in the proceedings that is greater than the interest that the general public has due to my interest in the environment and previous roles as a Carterton District Councillor from 2001-2022 and was certified as an RMA Commissioner for six years.

I have been co-opted to the South Wairarapa Whenua Advisory Group as an independent facilitator to co-ordinate community engagement and consultation.

I am not\* a trade competitor for the purposes of [section 308C](#) of the Resource Management Act 1991.

I am not directly affected by an effect of the subject of the appeal that—

- (a) adversely affects the environment; and
- (b) does not relate to trade competition or the effects of trade competition.

I am interested in all the proceedings.

I am interested in the following particular issues:

- Regulation that is required to mitigate adverse impacts and effects on neighbouring properties and urban areas close to the sites of solar farms
- Community consultation and engagement that is needed to educate the community of the pros and cons of this technology in a balanced way
- The advancement of how this technology is rolled out nationally with minimal impacts to communities, neighbouring landowners and the health of our agricultural land

I support the relief sought because I believe:

- Many landowners who I know personally will be affected by this development



- My family came to Greytown in 1852 as the first pioneers, I was bought up there and still have social and historical connections (I live 7 kms away in Carterton)
- Concerns that research that has been done internationally showing more than minimal effects is not being taken seriously by the Solar farm companies and our regulators.
- Concern that an application in Carterton on Norfolk Road was a non-notified consent.

I agree to participate in mediation or other alternative dispute resolution of the proceedings.

#### **Note to person wishing to be a party**

You must lodge the original and 1 copy of this notice with the Environment Court within 15 working days after—

- the period for lodging a notice of appeal ends, if the proceedings are an appeal;  
or
- the decision to hold an inquiry, if the proceedings are an inquiry; or
- the proceedings are commenced, in any other case.

Your right to be a party to the proceedings in the court may be limited by the trade competition provisions in [section 274\(1\)](#) and [Part 11A](#) of the Resource Management Act 1991.

The notice must be signed by you or on your behalf.
