1. **Auckland Council** wishes to be joined as a party under section 274 of the RMA in relation to the appeal lodged by Auckland Transport under section 157 of the LGATPA against the decision of Kiwirail Holdings Limited on a designation included in the Auckland Unitary Plan, namely, Designation 6303: Avondale to Southdown Rail Line from Soljak Place, Mount Albert to Neilson Street, Te Papapa (**Designation 6303**).
2. **Auckland Council** claims status to be heard on the appeal as the relevant local authority.
3. **Auckland Council** is not a trade competitor for the purposes of sections 308C or 308CA of the RMA.
4. **Auckland Council** is interested in the appeal as it may potentially overlap with a separate appeal by the Council against the decision of Kiwirail Holdings Limited on Designation 6303 (Environment Court reference ENV-2016-AKL-000276).
5. **Auckland Council** supports the relief sought in that it seeks to enable the Appellant to exercise its statutory functions and powers as a road controlling authority.
6. **Auckland Council** agrees to participate in mediation or other alternative dispute resolution of the proceedings.
