1. INTRODUCTION

- 1.1 Timberlands Limited ("TL") wishes to be party to the following proceedings relating to appeals against the decisions of the Waikato Regional Council on Proposed Waikato Regional Plan Change 1: Waikato and Waipa River catchments ("PC1").
 - (a) OJI Fibre Solutions (NZ) Limited v Waikato Regional Council (ENV-2020-AKL-000083);
 - (b) Fonterra Co-operative Group Ltd v Waikato Regional Council (ENV-2020-AKL-000084);
 - (c) Auckland Waikato and Eastern Fish and Game Council v Waikato Regional Council (ENV-2020-AKL000101);
 - (d) Federated Farmers of New Zealand Incorporated v Waikato Regional Council (ENV-2020-AKL000102); and
 - (e) CNI Iwi v Waikato Regional Council (ENV-2020-AKL000103).

2. NATURE OF INTEREST

- 2.1 TL made a submission and further submission on Plan Change 1.
- 2.2 TL has an interest in the proceedings that is greater than the general public in that TL is responsible for the management of over 34,000 hectares of plantation forest in the Waikato River Catchment.
- 2.3 TL is not a trade competitor for the purposes of section 308D of the RMA.
- 2.4 TL is interested in the appeals as a whole.

(ii) a workable approach that achieves the long-term improvement objectives of PC1 while providing for changes to land use.
